1. APPOINTMENT TO AUDIT COMMITTEE

Rick Crabtree, City Manager, reviewed the staff report and provided staff's recommendation that the City Council make an appointment to fill the current vacancy on the Audit Committee from the application received from Amy Schutter.

**2. TENTATIVE PARCEL MAP 14-10 & PDUP
385; 2800 MAIN STREET; AM-PM
CONVENIENCE STORE**

Scott Friend, Interim Community Development Director, reviewed the staff report and provided staff's recommendation that the City Council:

1. Adopt Resolution No. 4-2015, making findings for the denial of applications numbered Tentative Parcel Map 14-10 and PDUP 385 based upon the direction provided by the City Council following the Public Hearing held on February 3, 2015: OR
2. Adopt Resolution No. 3-2015 approving Tentative Parcel Map 14-10 and PDUP 385 with the Findings and Conditions of approval shown in City Council Resolution No. 3-2015; OR
3. Provide alternate direction to staff.

On Tuesday, February 3, 2015, the City Council held a duly noticed and advertised public hearing to consider a request to divide an existing parcel and approve a Planned Development Use Permit (PDUP) at 2800 Main Street (AM/PM Convenience Store). Following the presentation of the project by staff, the City Council conducted the public hearing and deliberated on the project. At the conclusion of the Council deliberation period, and following a thorough discussion and review of the proposal, the Council determined that there was not sufficient interest to approve the project and no motion was presented to approve or deny the applications.

Section 20.4, Specific Procedures for Subdivisions of the Red Bluff Municipal Code establishes that the City Council shall “approve, conditionally approve or disapprove the tentative map...” to conclude the requested action. Following the conclusion of the public hearing on February 3, 2015, no action was taken by the Council on the matter. If no action is taken to approve or deny a proposed parcel map, that map may become “deemed approved” by operation of law. (Govt Code Section 66452.4) Accordingly, staff recommends that the City Council take action to either approve or deny the proposed tentative parcel map.

Randy Zumalt expressed his concerns with the proposed parcel map.

Dave Dhugge, owner, stated that he was available to answer any questions the Councilmembers may have.
