- Miranda reported that City Council passed the last step of applying for the Splash Park grant 4-0.
- Phillips reported on the progress of obtaining more information about the City insurance carrier, Alliance Insurance. There are 40 cities in this consortium. Corning is also part of Alliance Insurance She has a meeting with Rick Crabtree tomorrow. Before the meeting, Phillips will contact Corning City Manager, Christine Miller, to inquire how they are able to allow bounce houses.

- Miranda reported that California Parks & Recreation Office of Grants and Local Services. They provide other varieties of funding. She e-mailed this information to Rick. If our agency has had a ballot measure between 2012-2018 aimed at enhancing and improving local or regional park infrastructures, then we would qualify. The minimum grant is \$250,000. Our last election quarter cent sales tax. Fifteen percent of it was supposed to go to parks. As a commission we should follow up with last year's sales tax report and then calculate how much we should be receiving. Vici feels we qualify for this grant. Ideas for park improvements were Forward Park parking lot, Lots for Tots, Trainor Park softball lights, fence around Skateboard Park.
