## **A. PLEDGE OF ALLEGIANCE**

Citizen Tony Carbonell led the Pledge of Allegiance.

## **B. CITIZENS COMMENT:**

Tony Carbonell proposed adding an adult non-contact floor hockey league to current City Recreational offerings. Mr. Carbonell He expressed an interest in volunteering to help get the league off the ground by providing expertise and some equipment, including a portable rink barrier and goals.

Mr. Carbonell emphasized the importance of safety in the league. He brought in a sample of the rubber ball that is used for floor hockey to demonstrate their low-impact design. Mr. Carbonell also proposed using helmets with face shields as a proactive way to ensure the safety of participants. Helmets and face shields are not used in the childrens league organized by Mr. Carbonell.

Commissioner Martin asked what deterrents have prevented a league from starting in the past. Mr. Carbonell responded that he believes that liability has been a concern.

Mr. Carbonell's proposal indicates that the league would be self-sustaining after the second season based on five teams participating at \$150 entry fee per team.
