**3.New Pool Hours and Fees (Action Items)**

Recommendation: That the Parks & Recreation Commission approve the new pool schedule and fees.

Discussion: Shaffer clarified that we cannot ask for a new fee schedule at this time. City Pool Manager Aislyn Lair is recommending that we approve new pool hours from M-Fri 1:30 to 4:30 and Tues evening 6:30-8:30 to Mon-Sat. 3:00 to 7:00pm. We are adding one hour and moving the public swim to later in the day.

Action: Motion to recommend adding one hour to public swim and changing the times to 3:00-7:00 pm Monday thru Friday.

2. Vici updated us on her grant proposal to City Council. She is requesting the City hire the grant writer for \$8,000. If the City applies for this grant it will make it more competitive with other grants. She plans to add the purchase of land, eight pickleball courts, outdoor gym equipment, music area, amphitheater /stage, remove/replace horse shoe pits, and remove/replace the B.B.Q. area. If the City doesn't approve to hire the grant writer for \$8,000, Soroptimist will continue with the Splash Park by themselves.
