### **2. Report on Tehama Together Dog Park Meeting**

Recommendation: That the Parks & Recreation Commission receive the report from Tehama Together's Dog Park Committee meeting.

Discussion: Chairperson Phillips and Commissioner Martin attended Monday's meeting. Phillips reported that the committee was eager and capable. Martin shared that the sorrow of Sharon Wintle's passing stirred community members to get involved, donating funds, materials and services toward the park. One

of the conditions of the donations is that the park be named “Sher Wintle Memorial Park” in her honor.

Tehama Together has agreed to form Friends of the Red Bluff Dog Park as a Citizens Management Organization to satisfy the conditions of the City Council’s approval. FotRBDP, under the auspices of Tehama Together, will solicit and coordinate ongoing community support for the operation of the park.

Commissioner Martin clarified that this would mean that the Commission would not make any decisions regarding the construction of the park without feedback from FotRBDP.

Action: MSC Martin, Reyes 3-0 to designate FotRBDP, under the auspices of Tehama Together, as the Citizens Management Organization to manage the dog park.

Music Camp was attended by 22 and continued the trend of recovering 100% of the cost for supplies and part-time staff.
