### **2. Parks Tour**

Recommendation: That the Parks & Recreation Commission set a date for the annual parks tour.

Discussion: Recreation Supervisor Hurton shared Parks Supervisor Skelton's recommendation to wait until the end of the summer season for the parks tour in order to view the facilities at their best. The commission will revisit the parks tour in August.

### **3. McGlynn Pool 80<sup>th</sup> Birthday**

Recommendation: That the Parks & Recreation Commission consider involvement in the 80<sup>th</sup> Birthday Celebration for the pool.

Discussion: Recreation Supervisor Hurton invited the Commission to participate in an opening

#### **4. Dog Park Progress Update**

Recommendation: That the Parks & Recreation Commission receive an update on dog park progress from Commissioner Martin.

Discussion: Commissioner Martin reported that he continues to work with the Public Works Department to complete construction. The Dog Park Committee decided against installing drinking fountains. More decomposed granite will be delivered and an ADA sidewalk will be installed prior to opening. An opening date has not yet been established.

#### **1. Recreation Report**

Recreation Supervisor Hurton reported that three volunteer projects have been approved for City Parks.

1. Trainor Murals
2. Lots For Tots Painting
3. Skate Park Graffiti remediation

The proposed murals on the scoring booths of Frey and Tosh fields will indicate the field names. Marquez will be joined by 7 fellow seniors in the project.

The commission expressed great appreciation for her art work and enthusiasm for the project.

Commissioner Martin suggested clear coating with a uv protection.

Recreation Staffing – Halley Reed has been hired as the new Lead Recreation Coordinator and will start on May 15<sup>th</sup>. Interviews have been scheduled for the final two Recreation Coordinator positions. A new Recreation Maintenance Worker has been hired and will begin training on May 15<sup>th</sup>. All pool positions have been filled conditioned upon the successful completion of the Red Cross Lifeguard class and/or Water Safety Instructor class.

Hurton has 5 students registered for the Lifeguard class that will be held on May 13<sup>th</sup> & May 20<sup>th</sup>. Swim

lesson registration is open and the Community Center has begun to receive private party reservations.
