D. STAFF REPORTS

Recreation Report: Shaffer reported that due to the COVID restrictions in the County that events are still not being scheduled. The County started vaccinating the public today at the Community Center. We are hopeful that as soon as Tehama County moves out of the purple tier that we will be able to start events.

E. COMMISSIONER COMMENTS:

- Commissioner Miranda asked about the progress of removing the fence around the Skate Park. Shaffer stated the agenda report had been submitted but wasn't sure when it would or if it would go to City Council.
- President Phillips congratulated Commissioner Torres on the success of the Christmas Festival and asked Torres to report on how the festival went.
- Commissioner Torres reported that 927 children were served. She also felt it was great success and she said that the committee isn't sure if they will move inside next year due to how many children were able to be come to the event. The community support this year was also great.
- Chair Phillips reported that she, Mike Skelton (City Maintenance Supervisor), Shaffer and others met at the Dog Park to discuss the future maintenance of the park earlier this week. She also stated that Jenny McHenry from NVS has offered to help maintain the park. Her organization maintains several county parks for a nominal fee. Phillips also asked that the park be on the agenda for discussion.
