**1. Auxiliary Pool Resurfacing Update**

Recommendation: That the Parks & Recreation Commission receive an update on the auxiliary pool resurfacing project.

Discussion: Recreation Supervisor Hurton updated the Commission with project status. The project is now hoped to be completed sometime in July.

**2. Dog Island Restroom Project Update**

Recommendation: That the Parks & Recreation Commission receive an update on the Dog Island Park ADA restroom project.

**2. Sher Wintle Memorial Dog Park Progress Update**

Recommendation: That the Parks & Recreation Commission receive an update on dog park progress from Commissioner Martin.

Discussion: Commissioner Martin reported that the parks have been floated and sprayed to address grass growth. 125 Tons of decomposed granite have been delivered to the parking lot. Ben Sale Trucking will provide equipment to move the decomposed granite to the park. Park signs have been delivered to the park.

**D. STAFF REPORTS**

**1. Recreation Report**

Recreation Supervisor Hurton reported that pool staff have introduced new snack bar options in an attempt to recover profitability. More than sixty swim lesson registrations have been submitted thus far. Season pass sales have been positive, but general admission has been down, possibly related to cool weather the opening week. Lifeguards Colten Leonard and Emily Grissom applied for and received a \$500 grant from the Red Bluff Community Center Auxiliary to purchase 28 lifejackets which are available for loan to patrons.

Summer softball will start next week, featuring seven teams each in the men's and coed divisions. This is consistent with last year, but lower than historic participation levels.

The Summer Fun Zone kids program has over fifty kids enrolled, but has fallen short of last year's numbers. Registrations continue to come in.
