### 2. Softball Rules

Supervisor Hurton presented a revision of softball league rules. He answered questions and received input and affirmation from the commission.

### 3. Disc Golf Update

Supervisor Hurton presented documentation including an agenda and minutes showing that the Parks & Recreation Commission, Technical Advisory Committee and City Council had approved the installation of a disc golf course at Dog Island Park exclusively on City of Red Bluff's portion of the park. The commission discussed how this sheds new light on the requests from Hyzer Ryderz for City involvement with the course.

## **E. STAFF REPORTS**

### 1. Recreation Report

Supervisor Hurton reported that he has successfully completed Red Cross courses certifying him as a Lifeguard Instructor (LGI) and Water Safety Instructor (WSI). The City of Red Bluff requires one WSI to oversee the swim lesson program, so Supervisor Hurton's certification will allow McGlynn Pool to offer lessons this summer. He will work toward getting all instructors WSI certified, which would qualify the City of Red Bluff's program as a Red Cross Learn to Swim program.

Supervisor Hurton reported that Fun Zone will have a significantly increased attendance as more students have prepaid for the entire summer than have attended in the past. Changes to collecting fees up front and requiring full week registrations have led to a forecast of triple revenues when compared to summer 2014.
