## **3.Prop 84 – Statewide Park Development and Community Revitalization Program**

The Commissioners were presented with a postcard announcing a community involvement meeting to be held on January 26, 2010 at the Community Center along with blank maps of Trainor Park and the River Park.

The Commissioners offered several suggestions and it was decided to have a preliminary meeting before the January 26, 2010 community meeting to form a plan for the meeting.

Other suggestions:

Add the words “dream” and “design” to the postcards.

Make a check list of park improvement ideas to hand out to community.

Water features must be underground to avoid breakage from vandals.

Involve Salisbury High School students in creating a volunteer program to increase grant points.

Set up a table at Vista School with park maps and allow students to design a park.

Set up meetings during pick up times from the SERRF program at Vista School.

Offer refreshments at meeting.

Talk about the grant during Little League's weekend registration and other organizations such as, Top Fuelers, Coca Cola league, Soccer sign-ups and the Tehama County Bulls.

Add a structure to the River Park for weddings.

Post the invitation on the City of Red Bluff website.

Post in newspapers and radio stations.

Get input from the Special Ed group at the surrounding schools.

Ask for help from the Elks, Moose and Kiwanis, Red Bluff, Down Town Association, Dr. Ron Clark and Goldie's Group.

Commissioner Avila volunteered to go door to door at the Kimball Crossing Apartments to discuss the Prop 84 grant and to pass out survey cards in an effort to involve the Community. Commissioner Morehouse volunteered to accompany Commissioner Avila.

#### **4. Commissioner Comments**

Commissioner Avila said he can be contacted at Fast Wheels Bike shop if anyone would like to get together and brainstorm.

Commissioner Morehouse expressed he was glad to be here and he looks forward working with everyone.

Commissioner Wigno said she is willing to help with anything needed.

He suggested if the City Pool is out of commission, can the City donate money to update the high school pool because the McConnell foundation will match the funds.
