Wine Tasting: The Annual Wine Tasting at the McGlynn Pool is July 17, 2010. There will be a live band, 6 wineries and Jack the Ribber will be serving food for \$5. The tickets are \$20 and there are door prizes and a silent auction.

Disc Golf: Director Carlisi reported that she is getting a check for \$5,000 from an anonymous donor deposited into the bank and the Disc Golf people are clearing areas at Dog Island Park.

Grant Update: Director Carlisi met with Kurt Weber from the California State Parks at the River Park and Trainor Park. Assembly Member Nielson's office has contacted Debbie and wants to write a letter of support.

Meetings Moved: Director Carlisi explained that in order to save money at the Community Center, it was better to have the Commission meetings moved back to the Council Chambers.

### Commissioner's Comments

Commissioner Morehouse expressed thanks to Director Carlisi for all of the work she is getting done with limited resources.

Commissioner Shaffer asked if the City of Red Bluff is going to lay off positions in the Parks. Director Carlisi informed the Council that it is going back to council next Tuesday.

Commissioner Avila said he would brainstorm with his wife and co-workers to try to think of ideas to help the Parks Department.

Commissioner Sousa said the people who stood up and spoke at the City Council Meeting on the Parks and Recreation's behalf did a lot of research and had a lot of passion.

Chairmen Piffero asked what the \$35,000 pool expense consisted of. Director Carlisi reported \$35,000 consists of chemicals and payroll are the largest expenses.
