D. Current Business:

3. **Prop 84 – Statewide Park Development and Community Revitalization Program:** Director Debbie Carlisi reported the Prop 84 grant was

4. **Lake Red Bluff Mitigation Advisory Committee:** Director Carlisi asked the Commission to appoint someone to the Lake Red Bluff Mitigation Advisory Committee. Committee members will meet and discuss ideas on economical stimulation.

5. **Bicycle Racing:** Jarret Yount of Ride on Race Series gave the Commission an informal presentation of Cyclecross racing. Cyclecross involves riding a circuit course that's narrow and steep with added obstacles for a set time period against others in the same class.

Jarret requested the use of Forward Park for the last race of the season in order to have a central race track between Redding and Chico.

6. **Disc Golf:** Director Debbie Carlisi announced Brandon Grissom is looking at bringing Disc Golf to Dog Island Park again. He is looking at a

eighteen-hole course in the front area of Samuel Ayer. Brandon Grissom will give a presentation at the April 14, 2010 Commissioner's Meeting.
