Prop 84 –Statewide Park Development and Community Revitalization Program

Director Carlisi informed the Commission that both grants are with consultants until Friday June 10th and then will be mailed.

River Park Festival Update

Director Carlisi said the River Park Festival Committee met the previous Friday and will meet again June 14th to finalize the festival plans. She said three live bands are scheduled, portable restrooms are ordered, and the Registration fee for the crafters was lowered from \$100 to \$35 resulting in more crafters registering.

Director Carlisi said the three day festival begins Friday June 24th with a kick-off party at Wilcox Golf Course. Saturday the festival continues at the River Park during the day featuring a children's carnival, craft booths, water ski show, beer garden, a live band and swimming at the McGlynn Pool. Saturday night the festival moves to the Tehama County Fairgrounds for a dance and Sunday a fun run is scheduled at Red Bluff High School.

Director Carlisi reported the Red Bluff Community Center Auxiliary paid for 22 new tables for the Community Center.

Students from Senior Make a Difference Day donated \$144.81 for Funzone Camp Scholarships for needy children.

McGlynn Pool

Director Carlisi informed the Commission of the City Pool opening June 11 and enough money was raised for the pool to run for nine weeks.
