D. Current Business

1. Elections of Chairman and Vice Chairman

Chairman Fred Avilla opened the nominations. Fred Avilla nominated Tim Morehouse. Tim Morehouse nominated Rachelle Sousa to be the Chairperson since she is currently the second chair. There was a

ballot vote and Rachelle Sousa received the most votes.

Rachelle Sousa nominated Tim Morehouse for Vice Chair. There was a ballot vote and Tim Morehouse was elected Vice Chair.

2. Department Name

Due to the reorganization done by City Council the parks and Recreation department needs a new name. There was discussion on possible names. Rachelle Sousa thought an acronym like Chico (CARD) would be memorable. Amanda Wigno made a motion to table the department name. Fred Avilla seconded. Ayes: 7 Noes: 0

3. Brass Plaque for Crowley's

Director Carlisi had brought up the suggestion of a brass plaque thanking the Crowley's for their donation to the new structure. Amanda suggested we check the other plaque at the pool and do a similar style. Tim suggested using some phrase that includes restoring, preserving. Rachelle Sousa said to include the community involvement. Loretta Heisler suggested to have the Crowley's name, date

and a phrase thanking them for their generous donation and ongoing support. Debbie Carlisi will bring 3 ideas to consider and/or modify at our next meeting. Fred Avilla made a motion to table the plaque. Becca seconded. Ayes: 7 Noes: 0

4. Dog Park at Diamond Park:

There was a letter from Anthony Leon that was read at our last meeting suggesting a dog park at Diamond Park. Becca suggested involving Mr. Barrow from the high school CSF and Mr. Null to get some student volunteers to help keep it safe. Other discussion included freeway access, a community bulletin board. Director Carlisi said there is approximately \$18,000 left that we might be able to use.

5. Wi-Fi River Park: There was discussion about adding Wi-Fi to the pool area at River Park to bring more traffic in. Loretta Heisler mentioned maybe partnering with the Chamber. Director Carlisi said she would check with Charter about specifics. Patricia Phillips said we should also consider WiFi at the Dog Park when it is developed.

6. I-5 Signs: More signage is needed to get people off the freeway and back on.

It was motioned by Loretta Heisler to table until next meeting. Becca seconded the motion. Ayes: 7

7. Commissioners Comments: There were several positive comments about the attendance, input and positive direction the commission is going.
