2. NOTICE OF EXEMPTION; USE PERMIT NO. 15-001/386; TO ESTABLISH AND OPERATE A CHILD DAYCARE FACILITY IN A C-2 ZONING DISTRICT; 645 ANTELOPE BLVD., SUITES 32 AND 34; ASSESSOR'S PARCEL NUMBER 41-220-16; FRONTIER VILLAGE.

Scott Friend, Interim Community Development Director, reviewed the staff report and provided staff's recommendation that the Planning Commission determination on UP 2015-001/386, a request to the City of Red Bluff to permit the establishment of a child daycare facility on an existing developed parcel zoned with the C-2, Central Business District zone designation. All required notices and advertisements have been published and mailed (adjoining owners, responsible agencies, landowner, and general public).

Ms. Lacey Tweedt, applicant, has submitted an application to establish and operate a children's daycare center serving up to 36 children in Suites 32 and 34 of the Frontier Village commercial center. The daycare center will be licensed by the California Department of Social Services to care for 12 infants and 24 two to twelve year old children. The center will have three teachers for the infants, a qualified teacher for the preschool aged children, and a

qualified teacher for the school aged children.
Operating hours would be Monday through Friday
between the hours of 7:00 a.m. and 5:30 p.m.
