#### 6. PUBLIC HEARINGS/RESOLUTIONS:

Scott Friend, Community Development Director, recommended that the Planning Commission motion to adopt Resolution No. 11-2018; a recommendation to the City Council to amend the Red Bluff Municipal Code Chapter 25: Zoning, §25.25 Residential Zones and Permit Requirements, §25.79 Commercial Zones and Permit Requirements, §25.92 Industrial Zones and Permit Requirements, and §25.239 Definitions as presented herein and approval of the Categorical Exemption as presented.

Chairman Piffero opened the public hearing at 5:20 p.m.

Mr. Friend described the steps taken that lead up to the public hearing. He explained that staff reached out to local schools as directed by the Planning Commission and mailed a request for comments to all the superintendents of all the school districts in the area and received no comments in return.

Chairman Piffero, hearing no comments from the public, closed the public hearing at 5:22 p.m.

Chairman Piffero reported that one of the Red Bluff school board members expressed that they didn't feel affected by this change and that's why there were no responses.

Commissioner Reyes asked and received confirmation that if the Commission made the recommendation to Council to amend the code, would they would really just be bringing the code up to date.

Commissioner Mollenkamp stated that no one would be concerned until it affects their neighborhood.

Chairman Piffero agreed that the private citizen would be concerned versus the schools.

Commissioner Mollenkamp motioned to adopt Resolution No. 11-2018; a recommendation for approval to the Council amend the code as presented. Commissioner Reyes seconded the motion.

#### 7. CURRENT BUSINESS:

Scott Friend, Community Development Director, explained that Chairman Piffero's term expires in December and he has submitted a reappointment request letter. Next year in 2020 there will be 2 terms that expire.

Mr. Friend stated that the Commissioners will have a lot of fun being on the Planning Commission during the General Plan Update. He reported he would be meeting with the City Manager regarding the General Plan on Friday.

Commissioner Reyes asked if the Commission would be amending zoning, specs and ordinances.

Mr. Friend explained that the code changes are during "Part B" of the General Plan Update.

Vice Chairman Dale asked if there would be sub-committees working on the plan.

Mr. Friend answered that he would discuss sub-committees with the City Manager.

#### 8. STAFF REPORT

Mr. Friend updated the Commission on the following topics:

- Live Streamed City Council meetings can now be heard as they are in progress from home.
- County and City meetings regarding a homeless shelter on Vista Way.
- Uhaul plans for the RV covers, they are conditioned on a design review submission.
- Bureau of Reclamation fire fuel reduction; beginning with Dog Island Park, Reeds Creek and finally the Slough (Spider Island).
- Housing Element Update due August 20, 2019; staff received housing numbers from the State.
- Chairman Piffero requested an update on the former Walmart building.
- Mr. Friend reported that Ross Dress for Less is going in at South West Corner of the building and then a Marshalls will follow. Estimated completion of Ross is expected in late January 2019.

#### **RECOMMENDED COUNCIL ACTION:**

#### SUMMARY:

As directed by the City Council, the Deputy City Clerk re-advertised the remaining vacancies on the Planning Commission and the Parks and Recreation Advisory Commission. Advertisements were first published in the local newspaper for three consecutive weeks beginning October 14 and ending November 7, 2018, resulting in one application submittal for three empty seats. Advertisements were published again for two consecutive weeks in December, resulting in one application submittal for two empty seats. Robert James submitted an application for the Planning Commission and none were received for the Parks and Recreation Advisory Commission (student representation).

#### PREVIOUS COUNCIL ACTION:

At the December 4, 2018 City Council meeting the City Council appointed applicants to the various commissions and directed the Deputy City Clerk to re-advertise the vacancy on the Planning Commission and the Parks and Recreation Advisory Commission.

#### CITY FISCAL IMPACT:

City Commission appointments are volunteer positions. There is minimal budget impact for the cost of legal advertisement.
