## **3. Current Business**

### **3.1 Fixed Base Operator**

Director Henz reported on behalf of David Underhill of Cardan Aircraft Services. Henz reported Jet A fuel dropped \$0.23 cents per gallon and AV Gas dropped \$0.04 per gallon however Cardan didn't change their prices for the month of March because the price was based off of the last bulk purchase. Cardan's fuel sales totals for the month of March, increased by 2100 gallons.

Henz said the airport museum is open again after a brief closure due to a water leak.

Henz reported that the goats at the airport are gone but he expects to bring them back in October. Henz said he hopes to have the goats longer once he can determine the difference of what it would cost to hire goats versus what it would cost to pay an employee to mow and if it is feasible.

Henz responded to questions regarding controlled burns at the airport for weed control and air quality control.

### **3.2 Grant Closure**

Director Henz presented a grant closeout letter from Federal Aviation Administration (FAA). Henz said he has applied for a new grant for the runway design and is waiting to hear from the FAA and once they give him permission to proceed, he plans to take it to council for acceptance.

### **3.3 IASCO Communications**

Henz stated he has requested a follow-up meeting with Kyle Jerome and Dennis Churchill at Iasco Flight School on April 16, 2014 at 10:30 a.m. to continue with discussions and dialogue regarding Iasco's use of the Red Bluff airport.

Fereira stated Irwin Fust attended a flight instructors meeting at Iasco Flight School and should have information at the next Red Bluff airport commission meeting in May.

### **3.4 Airport Restaurant**

Henz recommended the City move the restaurant downstairs as it would minimize the closure of the restaurant and save the cost of the lift which would add up to several thousand dollars. He said there is a problem with the plumbing and he had to replace the grease trap.

Henz said he contracted with Judy Semington, a local architect to assist with the plans of the building to make sure we are

consistent with environmental health department requirements and to put together a plan for the kitchen and restaurant areas.

Chairman Ferreira suggested a grand opening once the renovation work at the restaurant is finished.
