## **2. Citizen's Comments**

Rob Schmid, Red Bluff Council Member, provided direction to the Airport Commission and suggested the Commission become more involved in the business side of the airport, especially in areas of the budget and grants.

Rob Schmid inquired why the new Commissioner was not present at the Airport Commission Meeting.

Rick Crabtree, City Manager/Attorney, explained the new commissioner assumes office the beginning of the New Year.

Ken Johnson, audience member, reported the Tehama County Aviation Association (TCAA) is getting closer to their goal to place an aircraft display at the Red Bluff Municipal Airport. He invited the Commission to the TCAA meeting scheduled for January 26, 2017 at 6 p.m. at Leigh and Val's Wings & Wheels Restaurant.

## **3. Current Business**

### **3.1 Fixed Base Operator (FBO) – Cardan Aircraft Services**

Gary Walker, Cardan Aircraft Services, reported that the heater in the terminal lobby is now working. Also that

somebody ran into the fence by the south gate but probably was not aware that they left their license plate.

Chairman Ferreira inquired if there was any more theft. Walker reported there was a hangar with the lock cut off but nothing was stolen.

### **3.2 Commissioner Appointments**

Mr. Crabtree announced that Wanda Schuler and Dave Cappello were appointed by the City Council at the last meeting to each serve four-year terms.

placed on the next City Council agenda for approval to award the job to the Door Company.

Commissioner Moore inquired if the Door Company is local. Mr. Crabtree reported the Door Company is from Redding

Commissioner Moore inquired if City Staff was able to locate an Environmental Impact Report (EIR) for the lengthening of the airport runway.

Mr. Crabtree stated that there is no EIR for the runway lengthening.

Council Member Schmid suggested the aircraft display be placed by the Harry Johnson hangar.

Chairman Ferreira adjourned the meeting at 6:49 p.m.
