5.3 **Miscellaneous Airfield Repairs** Informational  
City crews were recently able to make structural repairs to the large windsock cage and replace the fabric on all three assemblies. While on-field, they were also able to repair the supports of a few taxiway informational signs at the intersections adjacent to the ramp.

6.1 **Visibility of PAPI lights** Discussion  
Staff has been alerted by an individual pilot that the PAPI lights are difficult to see. Staff is inquiring if the Commissioners have heard any other similar complaints or have experienced the same difficulty for themselves.

6.2 **New UAS Regulations** Informational  
New regulations have been released that allow, for qualified drone pilots, access to flight operations in certain controlled airspace, at or below 400 feet. Perspective recreational and Part 107 drone pilots can obtain airspace authorization through the Low Altitude Authorization and Notification Capability (LAANC) system.
