4.1 **IASCO Operational Concerns at RBL** Informational

Early last month, the Airport Manager met with Captain McConkey of IASCO at his office in Redding regarding operations at, and about, RBL. Items discussed were;

- a) Student congestion in traffic pattern.
- b) Erroneous reporting of position.

- c) Not fully stating student's intentions during transmissions ("touch and go", "full stop", etc.).
- d) Deterioration of intelligible communications.
- e) Not observing Calm Wind Runway conditions.
- f) 10-12 mile calls for straight-in final for Rwy 33.
- g) Extended holding over VOR.

Captain McConkey was also informed of anticipated increase of traffic at RBL with Vina Helitack Base relocation, fire season prevention/survey flights and incident responses, and Red Bluff Police Department sUAS operations. He was also informed of the new avionics shop on-field and the expansion of the aviation upholstery shop. He was reminded that the Wings and Wheels Restaurant is newly remodeled and invited him and his students to stop in for a meal or a cold refreshment during one of their trips to RBL.

4.2 South Jackson Street Improvements

Road improvements were started on June 18th with the concentration being on the east side of the road between Vista and Kimball getting the curb, gutter, and sidewalks installed. Roadway grinding, and paving is scheduled for July 9-13 with micro surfacing and striping for July 16-20. Expect daily detours 7:00am - 5:00pm.
