3.2 **Red Bluff Police Department sUAS Operations** Advisement

The Red Bluff Police Department has purchased a sUAS "drone" to assist them in the performance of their law enforcement and SAR duties. They have obtained a *Certificate of Waiver or Authorization, Part 91* to operate from the surface to 400 feet AGL within the area of RBL under the jurisdiction of Oakland ARTCC. Horizontal range is approximately 40 statute miles to the east, 15 to the north, and 24 to the

south. Flights will operate under a NOTAM, the PIC and VO are required to monitor the local airport advisory frequency, and yield to other aircraft, manned or unmanned. The Department will staff a few officers as certified sUAS Pilot in Command and Visual Observers for drone operations.

The Department has requested an Authorization Letter from the Airport Manager that would permit the drone manufacturer to unlock operational software restrictions that currently prohibit flight operations within RBL airspace. Prior to providing letter to the Department, the Airport Manager seeks comments from the Airport Commissioners.

### **3.3 South Jackson Roadway Improvements**

### **Informational**

South Jackson roadway improvements will begin construction on June 18 and continue through mid-July. Limits are from Luther Road to 80+ feet past the Vista Way intersection. Project will consist of micro-paving, grind-and-replacement of Hot-Mix Asphalt, and installation of sidewalks at missing locations. During certain construction periods, So Jackson will be closed with detours redirected to Airport Blvd and Vista Way. So. Jackson will be reopened for normal traffic at the end of each closure day.

PJ Helicopter's new hangar construction project has gone vertical with structural steel. The waterline extension along, and from, So. Jackson to the facility is nearly complete.
