5.2 **Aircraft with Blown Tire Stranded on Runway** **Informational**

At approximately 21:30 on Sunday, September 30, the Airport Manager received a call from Red Bluff Police Department Dispatch, stating that an aircraft was stranded on the runway with a blown tire. Police provided emergency lighting at the immobile aircraft and FAA was called to file a NOTAM regarding a temporary runway closure. FBO was notified and Airport Manager arrived on the field. Prior to managers arrival, the pilot and passengers of the Cessna 182T were able to push the aircraft off the active runway. The manager inspected the runway for FOD and only minor wheel fairing debris from the subject Cessna was found and removed. Visual inspection of the tires revealed that they were all badly worn, and no discernable tread was remaining on either main wheels. Pilot and passengers arranged for ground travel back to Palo Alto and FBO coordinated with aircraft owner for needed repairs.

5.3 **Council Issues Resolution for 10-year Homeless plan** **Informational**

At the October 2<sup>nd</sup> City Council meeting, the Council members voted to issue a Resolution in support of the County's 10-Year Plan to End Homelessness. The Document can be found in its entirety in Agenda Item 9 through the following hyperlink;

While not specifically named in the document, the existing Tehama County Health Services Agency building located at 1445 Vista Way, was discussed as the potential future location of the One Stop Navigation Center that is addressed on page 40. The discussion also mentioned that the 1445 Vista Way location would also provide an expansion of services that would include overnight shelter services with it's new designation. While the Plan's purpose is to layout the practical strategy for addressing the problem of homelessness in Tehama County, no specifics of its implementation or future operational protocols have been established at this time.
