1. Approval of Minutes

Commissioner Chamblin motioned to approve the September 10, 2014 minutes and Moore seconded the motion.

2. Citizen's Comments

Hangar owner Dave Hall suggested the City mount the old beacon light onto a cell tower. He said the old beacon wasn't tall enough but if an old cell phone tower could be utilized to compensate for the height, it would work.

Irwin Fust of Tehama County Aviation Association announced that on October 11th he is holding a planned work day to move all of the items from the airport museum into a storage unit that Cardan Aircraft Services has made available.

3. Current Business

3.1 Fixed Base Operator (FBO)

David Underhill of Cardan reported that September was a quiet month. He said gross fuel sales were down 800 gallons and AV Gas was down \$0.01. Jet A was also down \$0.06 bringing Cardan's price down to \$5.59 per gallon.

Director Henz reported that the City Council had requested that the airport commissioners provide their thoughts and opinions relative to the extension of the Cardan Fixed Base Operator's Lease Agreement. The Commission held a brief discussion and voiced their unanimous support for the contract extension.

3.2 Airport Restaurant

Henz reported that he had requested a schedule from Semingson's Architects regarding the relocation of the airport restaurant and he was looking at ways to make the move easier. He said the architect was waiting on some structural information and then she would give her recommendation.

3.3 Airport Gates

Henz said he got a quote for the internal controller parts that operate the south gate. He said if he spent \$4800 on the controller mechanisms and didn't replace the external gate, he could buy high quality parts versus replacing both the internal parts and the external gate for \$5000 and lower quality.


Comments
