### **1. Approval of Minutes**

### **2. Citizen's Comments**

Irwin Fust of Tehama County Aviation Association (TCAA) announced he is offering another Aviation Ground School beginning March 13, 2014. It is an eleven week course and he added a flight simulator toward the end of the class.

Chairman Don Ferreira commended Kyle Jerome, and Matt Lazenby of Iasco Flight Services and everyone else that was involved for keeping the conversation pleasant at the last Airport Commission Meeting when it could have been contentious.

Tom Jaharis of Cardan described his experiences with communication issues with Iasco student pilots. There was open discussion regarding solutions to the communication issues and untimely flight schedules.

### 3. Current Business

#### 3.1 Fixed Base Operator

Tom Jaharis of Cardan distributed a list of local fuel prices and explained the weekly wholesale fluctuations. He said that Cardan's prices have remained the same.

#### 3.2 Various Airport Business

Director Henz reported he is trying to close out the grant for the Airport Layout Plan (ALP). He distributed copies of the final invoice to the Federal Aviation Administration (FAA) and a copy of the new grant for the runway rehabilitation design along with an executed grant receipt from the FAA. He stated he expects the old grant to close and is working on the contract between the city and the airport consultant for the new project.

Henz said the weed abatement from the goats was going well and he would consider a contract in the spring due to the street department expected to be busier in the streets.


Henz discussed the possibility of supplying electricity to hangars.
