## REGULAR AIRPORT COMMISSION MEETING

### 1. Approval of Minutes

Commissioner Chamblin motioned to approve the minutes and Commissioner Moore seconded the motion.

### 2. Citizen's Comments

Dave Hall, hangar owner, suggested the City arrange the commission meeting dates closer to the City Council meetings so it would be easier for the commissioner to remember the airport issues brought up in the commission meetings when they are giving their report to Council.

Director Henz clarified that there were two Council meetings a month and the Commissioner wouldn't have that long of a span in between meetings.

### **3. Current Business**

#### **3.1 Fixed Base Operator – Cardan Aircraft Services**

Gary Walker, owner of Cardan Aircraft Services, reported that none of the hangars were broken into during the prior month but he suspects someone may have siphoned some fuel from the fuel truck and one plane was drained of fuel because it was left out overnight. He noticed the police were patrolling more often last month, which probably has decreased the number of break-ins.

Commissioner Wulfert complimented Walker on how good the landscaping looked at the terminal.

#### **3.2 Airport Surveillance Cameras**

Director Henz provided information from the last City Council meeting about the installation of surveillance cameras at the airport. He is exploring different Wi-Fi options and the Police Department has been helping with suggestions.

Walker commented that his current Wi-Fi was terrible and he wants to change to Spectrum but needs additional customers to make it worthwhile for Spectrum to run the cable to the airport.

Chairman Ferreira warned there are different costs for cameras depending on what you want them to do.

### **4. Old Business**

#### **4.1 Runway Rehab**

Director Henz reported the runway rehabilitation bids came in at significantly lower amounts than expected and the lowest responsive bidder was Tullis Construction out of Redding. The Federal Aviation Administration requested a break-down of costs to permanently stripe the runway at night time before they will send a grant confirmation.

### **5. Comments**

Director Henz reported the beacon was inoperable for a short time and staff changed a photocell to make it operable again.

Commissioner Moore reported that the airplane wash rack was not working.

Director Henz announced that this was his last commission meeting. He submitted his resignation and he expressed to the commission that it has been a pleasure to work with them.

Chairman Fereira adjourned the meeting at 5:55 p.m.
