The Agenda is divided into two sections:

**CONSENT AGENDA:** These items include routine financial and administrative actions and are usually approved by a single majority vote. Any City Councilmember, staff member or interested person may request that an item be removed from the Consent Agenda and those items are usually considered following approval of the remaining Consent Agenda.

**REGULAR AGENDA:** These items include significant financial and administrative actions of special interest that are usually approved individually by a majority vote. The Regular Agenda also includes noticed hearings and public hearings. The times on the agenda are approximate.

The deadline for items to be placed on the City's agenda is 5:00 p.m. on the preceding Tuesday, unless a holiday intervenes. Items not listed on the Agenda can only be considered by the City Council if they qualify under Government Code Section 54954.2(b) (typically this applies to items meeting the criteria as an off agenda emergency).

**A. CLOSED EXECUTIVE SESSION:**

- 1. CONFERENCE WITH LABOR NEGOTIATORS: Executive Session in accordance with Government Code Section 54957.6 for the purpose of instructing the City's designated representatives Martin Nichols, City Manager, and Tessa Pritchard, Human Resources Director, regarding the salaries, salary schedules, or compensation paid in the form of fringe benefits with the Police Unit, Fire Unit, Miscellaneous Unit, Mid-Management and Management Employees.**

## **B. CURRENT BUSINESS:**

### **1. FY 2010-11 BUDGET**

#### **Recommendation:**

The Budget Committee recommends that the City Council take the following actions:

1. Receive the Committee's Report
2. Adopt or amend Committee's Recommendations
3. Adopt Interim FY 2010-11 City Budget as a basis to authorize City Operations until a Final FY 2010-11 budget can be presented to the Council.
4. Until a final budget can be adopted and the results of discussions with employee organizations are known, the City Manager be directed to implement tight expenditure controls.

5. Direct staff to prepare a Final FY 2010-11 City Budget.
6. Adopt the following budget control policies:
  - a. Staff provides periodic budget reports to the Council on both actual expenditures and revenue changes.
  - b. Require all future vacant positions to obtain the approval of the City Council before being re-filled.
