### **BLUES FOR THE POOL DONATION**

## **POLICE CORPORAL**

Police Chief Paul Nanfito reviewed the staff report and gave staff's recommendation that the City Council:

1. Authorize a new supervisory position within the Police Department entitled Police Corporal, and
2. Re-classify (3) currently authorized Police Officer positions to that of (3) Police Corporal Positions. This is a re-classification of existing positions and not an increase in staffing. And

3. Approve the job description for Police Corporal, and
4. Approve the salary structure for the position of Police Corporal.

Police Chief Nanfito discussed the importance of having corporal positions for not only a financial benefit in the end but as well as from a liability standpoint.

Councilmember Carrel wanted clarification as to if making these 3 positions corporal positions will it help with retention.

Councilmember Jackson stated that she didn't like the idea of the police corporals' positions because we have already given so much to the Police Department already. We have such a top heavy department, are we really going to add 3 more positions to add even more chiefs.

Mayor Pro Tem Brown stated that he is proud that we have made a decision to get behind our police this year and that we have given more to them than anyone else this year and that he just wished we could have given them more.

Mayor Flynn stated he did not feel that everything has been for the Police Department and this was not an unreasonable request.

Jo Anna Lopez, City Clerk, stated that the raise that Council had given to the Police Department was not really a raise, as it was the cut that the Police Department gave when the Council was asking for cuts. She continued by saying that the Police Department had given up the most money in the City.

Councilmember Jackson stated that everyone was asked to take concessions, it was not just the police department.
