PUBLIC WORKSHOP AND STAKHOLDERS MEETING FOR INPUT AND COMMENT ON
THE CITY OF RED BLUFF HOUSING ELEMENT UPDATE 2019-2024**

WHAT IS BEING PLANNED:

Section 65302(c) of the California Government Code requires Cities and Counties to adopt Housing Elements as part of their General Plans to analyze issues of housing availability, affordability, and needs in their communities; and to set goals, policies, programs, and implementation strategies to address those issues. The General Plan Housing Element was last updated in 2014. As part of the housing element update process, the City is requesting public input on the draft 2019-2024 Housing Element and on what aspects of housing are of concern to the residents of the city. As such, a public workshop is being held at the time and place indicated below.

WHY THIS NOTICE?

The purpose of this ad is to notify you that the City of Red Bluff is collecting and preparing information related to the 2019-2024 Housing Element, which is available for your review and comment at the Planning Department in City Hall at 555 Washington Street in Red Bluff, CA 96080 or City of Red Bluff web page at cityofredbluff.org Therefore, if you have any questions, concerns or general input please do not hesitate to contact us as indicated above and/or attend the **Public Workshop scheduled for 4:00 p.m. to 5:00 p.m. on February 13, 2020 at City Hall at 555 Washington Street.**

Prior to submittal of the 2019-2024 Housing Element to the California Department of Housing and Community Development (HCD), a Planning Commission meeting and a City Council meeting will be noticed and occur. At these meetings, the public will also have the opportunity to provide input. The date of these meetings have not yet been determined.

Any concerned citizen, agency or organization. It is very important that we hear from local residents and concerned agencies/organizations on these issues. The information, perspectives, and insights of the citizens and agencies/organizations can become a vital part of the fabric of the Housing Element.
