GENERAL NOTES:

Initial

- ❖ ___ Call Underground Service Alert (1-800-227-2600) 48 hours prior to digging.
- ❖ ___ Provide shoring for all excavations per CAL-OSHA requirements.
- ❖ ___ All work shall conform to the City of Red Bluff Land Division and Engineering Design Standards, and the Standard Specifications for Public Works Construction (Greenbook),
- ❖ ___ Applicant is responsible for all job site safety.
- ❖ ___ All trench backfill within the Public Right of Way shall be per City of Red Bluff Standards.
- ❖ ___ Applicant to provide traffic control (auto and pedestrian) per the Work Area Traffic Control Handbook.
- ❖ ___ Permit expires one year from date of issuance.
- ❖ ___ Applicant agrees to guarantee all work within the Public Right of Way for a period of one year **after final inspection.**
- ❖ ___ Call for inspection of forms prior to placement of concrete (**24 hour minimum advance notice required**)
- ❖ ___ Call for inspection of water and/or sewer lines and connections prior to backfill (**4 hour advance notice required**)
- ❖ ___ City of Red Bluff to tap existing sewer line. No taps after 2:00 PM. Applicant agrees to provide all materials, properly shore the excavation and pay the fully burdened labor costs.
- ❖ ___ Call for final inspection (**24 hour minimum advance notice required**).

Note: Applicant waives any claim of liability or damages against the City of Red Bluff based on the issuance of this permit, on any subsequent court order declaring this permit invalid and on any future damages suffered by the applicant by reasons of the issuance of this permit or his reliance thereon, and agrees to do the work in accordance with City rules and regulations and is subject to City inspection and approval. Permittee agrees to hold the City of Red Bluff harmless from any liability arising out of the placement of this encroachment.
