## Parks and Rec Commission Comments

Vice Chairperson Miranda reported the dates that each Commissioners would report to the City Council on Park and Recreation Commission meetings.

Student Commissioner Sophia Drugovich reported the Fun Zone was going well. There are about 90 kids in attendance separated into 4 separate age groups. In July the program will move to the Community Center. The Fun Zone is also providing activities at the Farmer's Market.

Vice Chairperson Miranda reported that the first Red Bluff Community Band Concert was held at the River Park. She stated that there were about 120 people in attendance. Soroptomist served about 60 root beer floats and has agreed to continue to serve floats during the concerts. The band has been playing since 1948.

## Updates from Staff

Parks & Rec Supervisor Shaffer reported there were 90 kids enrolled in the Fun Zone program. More kids than normal are enrolled because all the schools are paying this year for an extended day. Schools are also paying for the four full weeks at community center. Staff will probably not be able to accommodate everyone if we don't close registration. We have

City League softball will play their championship game Monday June 19th. Playing for the championship is Brew Crew and Bud's Jolly Kone.

McGlynn City Pool opened June 10th. There were 160 people the first day. All entrance fees for kids are being paid for by the Active 20/30 Club, Rotary, Kiwanis, and Konor Fleharty Memorial Scholarship Foundation.

Swim less registration is closed and full. We have six water safety instructors (WSI) this year, a total of 11 guards and four cashier/snack bar workers.

We do not have diving boards this year due to them being cracked when we went to install them. We will reorder them for next year. Were told it would be 17 weeks before they would ship out.
