1. **Staff Report:** Commissioner Avila inquired if The "Ride on Bike Series" cleaned up after the bike race at Forward Park.

Director Debbie Carlisi said there were no issues and they cleaned up very well.

Chairman Steve Piffero said residents who live by Forward Park reported to him that they watched the Ride on Bike Series group haul off three pick up loads of pre existing trash and appliances.

2. **Disc Golf Presentation by Brandon Grissom:** Brandon Grissom presented a map of Dog Island Park which laid out the 18-hole Disc Golf Course he would like to install into the Park. He explained the costs and land requirements involved and said his group would handle the fund raising and he just needs approval to set up the course in the park.

Commissioner Avila motioned to recommend to the City Council to move forward on the installation of the Disc Golf course on Dog Island Park.

3. **Clean Up Dog Island on May 8th:** Dr. Robbi Dotson of the Church of Jesus Christ of Latter-day Saints informed the Commissioners of Mormon "Helping Hands" day to be held on May 8, 2010.

Dr. Dotson worked with Director Carlisi and Parks Maintenance Supervisor Mike Skelton in putting together a list of the needs of each Park in Red Bluff. He said the LDS will provide the manpower, tools, equipment, paint and liability insurance in order to make an effort to improve Red Bluff's Parks. They plan on getting as much done as possible on May 8, 2010 but they plan on continuing the park beautification throughout the next 20 to 25 years. Dr. Dotson stated that the church is not asking for anything in return only to make the Parks available so they can offer a day of service to the community.

Commissioner Sousa motioned to recommend to the City Council to move forward on the Mormon "Helping Hands" day.

Director Carlisi announced that Park and Recreation has 44 soft ball teams signed up and she calculated softball should bring in 700 people from out of town per week. She also announced that the Kay Wheeler Memorial Soft ball Tournament profited almost \$1500.00 to go towards the City Pool. She thanked Debbie Morish for umpiring all eight games and all of the volunteers that made the tournament possible.
