1. Staff Reports

2. Prop 84 – Statewide Park Development and Community Revitalization Program

Trainor Park

Parks and Recreation Volunteer Debbie Morish presented a spreadsheet of compiled data from the opinion cards completed by the community. The top requests from the community were new restrooms at Trainor Park, shelter, picnic areas and a spray park.

Commissioner Avila motioned to recommend adding a Dog Park, ball field, parking, restrooms, solar lighting, concession stand, Spray Park, and a lighted walking trail to Trainor Park.

The Blues for the Pool Committee recommended that the pool stays large versus sectioning it off into smaller pools, enclosing the pool with sides and a roof, adding a spray park where the old playground equipment is on the west side of the pool and replacing the playground equipment on the South side of the pool. Other recommendations were to add a walking trail and a new stage area (amphitheater).
