2. **Disc Golf Update:** An anonymous person donated \$5,000.00 to go towards Disc Golf at Dog Island Park.
3. **Park Clean Up:** Mike Skelton reported the Mormon Helping Hands Group painted one of the bathrooms at the River Park, a bathroom at Forward Park, leveled out the rough areas at Dog Island Park, cleaned up the horseshoe pits and painted the bathrooms at Dog Island as well.
4. **Grant Update:** Mike Skelton reported that Sacramento Representatives from the State of California department of Parks and Recreation are meeting Director Debbie Carlisi at Trainor Park and the McGlynn Pool to perform a site survey for the Prop 84 Grant. This means that the Grant acquisition has gone to the next level and that Red Bluff Parks are at least being considered.
