Skate Park

Director Debbie Carlisi reported the parks maintenance crew will be adding some landscaping and purchasing 2 benches with money from the Roberti-Zberg-Harris grant. Commissioner Avila inquired if the fence has been vandalized and Director Carlisi said there were no reports of the fence being cut recently.

Disc Golf Update

Director Carlisi informed the Commissioners that Brandon Grissom and Shane Emde from DIG (Dog island Golf) received the baskets and are almost ready to pour the pads. They are also soliciting donors for each of the eighteen baskets in order to purchase benches and trash cans.

Grant Update

Director Carlisi informed the Commissioners that the City of Red Bluff did not win the Prop 84 grant money however; the City of Corning was awarded 4.2 million. She explained that the city didn't receive the grant because the creation of new parks in other cities took priority and Red Bluff's median household income was higher than other cities. Director Carlisi said there is a second round in March to seek grant money and we could improve on our first try by holding more community meetings, updating what was done in the first round, and hopefully the 2010 Census will better reveal the poverty level of the families around the parks. John Brewer from Corning offered to assist us with our application in the next round. John Mason our grant officer from State Parks and Kurt Weber the Prop 84 project officer offered to help us as well.

Volunteer Recognition

Director Carlisi asked the Commissioners to attend the January 18th City Council Meeting so the Church of the Latter Day Saints, Scott Blanchard, Brandon Grissom and Shane Emde from DIG, and Mike Emigh could be recognized for their volunteer work in the parks.

Park Volunteers/Adopt a Trail

Director Carlisi informed the Commissioners that the trails at Samuel Ayer are over grown and suggested an "adopt a trail" program. She asked the Commissioner's to look at Redding and Chico's Parks programs online to get ideas on marking the trails and necessary rules. Chairperson Piffero volunteered calling Chico and Redding's Parks Departments.

Commissioner's Comments

Vice Chairman Avila said he was pleased to hear that the Skate Park fence has not been vandalized recently.

Commissioner Shaffer said he was sad to hear Red Bluff wasn't awarded the Prop 84 grant money.

Commissioner Wigno expressed her disappointment about not receiving the grants but said she's happy that Corning received grant money.

Commissioner Morehouse said the second round of acquiring the Prop 84 grant should be easier since most of the leg work has already been done. He informed the Commissioners that Shasta College Tehama Campus is breaking ground on a bike trail that will connect Woodson Bridge to Shasta Dam.
