#### 2. Pickleball Proposal

Commissioner Martin stated that any activity that could bring in revenue without increasing costs or damaging the building would be welcome.

<u>Action</u>: Motion to approve pickleball as a new sport for City of Red Bluff recreational leagues.

- <u>Discussion</u>: Commissioner Gamboa reported that there was minimal interest among his leadership class in forming a dog park committee. Gamboa offered to promote it to the rest of the school. Chairperson Phillips agreed to produce a flyer.

Supervisor Hurton reported that the crowdfunding campaign received good publicity, but only brought in \$280 in donations.

Commissioner Jensen offered to ask the RBUESD board for support in forming a dog park committee.

The commission discussed ways to gain more public awareness.
