C. CURRENT BUSINESS

- 2. Increase Team Fees (Action Item)

leagues from \$200 to \$300 and two umpire leagues from \$300 to \$400 a
season.

- Action: Motion to recommend staff to reinstate a softball tournament fee of \$200 per field per day. MSC Torres/Bentley 2-0 Miranda abstained.
