## **Recreation Report:**

Shaffer reported that the Adopt A Park program was passed by City Council. Miranda asked when groups could start adopting parks. Shaffer stated that until COVID restrictions are lifted we cannot start the program. Miranda also asked that there be a list of projects that need to be addressed in the parks so that when groups sign up to clean up a park, they have direction.

There was discussion about the Skate Park clean up and painting over graffiti. Miranda suggested we investigate building a ball wall or something like and designate it as a wall to express themselves through painting and art.
