D. STAFF REPORTS

Recreation Report: Shaffer reported:

- Lead Recreation Coordinator Laura Owens is back to work. She is working with SERF and Human Resources to start recruiting for Fun Zone staff. Laura also reported that the Department of Education is willing to help finance children who qualify for financial assistance this year.
- Shaffer reported that ten people have been offered employment for the pool. Seven of those have expressed interest in obtaining their Water Safety Instructors (WSI) certificate.

- Chair Phillips stated that the Red Bluff Garden Club would be having a plant sale May 1st at the Methodist Church on David Ave. 9:00 am to 2:00 pm.
